- a. The Board is responsible for the overall policy and direction of the organization and may delegate responsibility for day-to-day operations.
- b. The Board must approve the budget and any major changes in the budget. The Board receives no compensation other than reimbursement for reasonable expenses.
- c. The Board shall be administered in accordance with this approved Bylaws of the NOSC and other applicable directives under the supervision of the Board; unless otherwise provided herein or in the Bylaws, all business shall be conducted in accordance with Robert's Rules of Order, Revised.
- c. The Board shall carry out the purpose and objectives of NOSC by approving the transaction of its routine business in accordance with the approved Bylaws and shall make and enforce such Bylaws as are necessary for the governing of the NOSC.
- e. Board members are required to attend one board meeting monthly as scheduled and prepare necessary reports to the board to keep them apprised of their activities.
